Part 1 General

- **1. Related documents**: The provisions of the General and Supplementary Conditions and General Requirements (if any), apply to the work specified in this section.
- 2. Work included: In general, this includes, but is not limited to providing all labor, materials, and equipment for tile where shown on the drawings, as specified herein, and as needed for a complete and proper installation.
- **3. Shop Drawings and Product Data**: Submit in accordance with Section 01330 'Submittal Procedure'.
- **4. Substitutions**: Other manufacturers will be considered. Supply specifications sheet to Architect for approval.

5. Samples:

Tile: Submit two sets of samples illustrating color range for selection.

Grout: Cured samples showing available colors.

Part 2 Products


Project should be bid with the following as the floor and wall tile. The tile contractor may submit samples of similar tile to the Architect for consideration (after the bidding process) but should be prepared to furnish the specified tile

- **1. Restroom Wall Tile:** American Olean Fusion Cotto; 12" x 12", color to be selected and 3" x 12" bullnose trim, color to be selected
- 2. Restroom Floor Tile: American Olean Fusion Cotto; 12" x 12", color to be selected
- **2. Grout:** The grout shall be Tec Power Grout (www.tecpowergrout.com) manufactured by HB Fuller Co.
- **3. Crack and Anti-fracture Membrane**: All cracks and expansion joints in the concrete slab shall be properly treated with a crack isolation membrane system applied in a width equal to the size of the ceramic tile.
- **4. Transition Strips:** see list of transition strips in Carpet 09685 section.

Part 3 Execution

- **1. Preparation**: Seal substrate surface cracks with filler. Inspect substrates and ensure surfaces are free of coatings, curing membranes, oil, grease, wax, and dust.
- **2. Installation**: Install per manufacturer's recommendations and instructions. See Drawings for dimensions and field verify existing conditions.
- **3. Layout**: Layout tilework to minimize cuts less than one-half tile in size. Do not interrupt tile pattern through openings.
- **4. Joints**: Align joints to provide straight, uniform grout lines, parallel with walls. <u>Joint width shall be 1/8".</u>
- **5. Grout tile joints**. Make joints watertight, without voids, cracks, excess mortar or excess grout.
- **6. Grout haze**: Remove grout haze following grout manufacturer's recommendations.
- 7. Apply sealant to junction of tile and dissimilar materials and junction of dissimilar planes
- **8. Maintenance Instructions**: Include recommended cleaning methods, cleaning materials, and stain removal methods.
- **9. Job Conditions**: Maintain ambient temperatures at not less than 55°F, beginning 24 hours prior to installation of finishing systems, and thereafter to Substantial Completion.
- **10. Extra Stock**: Supply extra stock of 2% in marked cartons.




Plan View
